DEAR SIR:—You have submitted a lease executed by David N. Powell and Elden Powell on November 4, 1935, which describes 242.08 acres of land, more or less, situated in Blanchard Township, Putnam County, Ohio, and more particularly described in said lease which is numbered 2327.

By this lease, which is one for a term of five years, this land is leased and demised to the state solely for state game refuge purposes; and it is noted in this connection that, acting under the provisions of Section 1435-1 and other related sections of the General Code, the Conservation Council, acting through you as Conservation Commissioner, has set this property aside as a state game and bird refuge during the term of said lease.

Upon examination of this lease, it is my opinion that the same has been

properly executed and acknowledged by said lessor and by the Conservation Council acting on behalf of the state through you as Commissioner. Accordingly, I have endorsed my approval as to form upon said lease and the duplicate copy, both of which are herewith returned.
