Narrative:

On July 3, 2024, Special Agent (SA) Josh Rammel (Rammel) reviewed all radio traffic and radio logs from the Wood County Sheriff's Office (WCSO) regarding the WCSO response to a welfare check involving deceased individual George Eric Taylor (Taylor) that took place on June 16, 2024, at 8401 South Dixie Highway, Rudolph, Ohio.

The information contained in this report is just the dispatch information deemed important to the Officer Involved Critical Incident (OICI) investigation that stemmed from the initial welfare check call.

Due to the WCSO Dispatch utilizing unit numbers as opposed to names the information listed in this report will use the unit numbers as well as the name of the particular deputy.

- 1. Deputy Samuel Miller (Miller) is W75.
- 2. Sergeant Chris Reynolds (Reynolds) is W27.
- 3. Deputy Michael Shaffer (Shaffer) is W70.

Unit 75 was dispatched to the welfare check on Taylor at 00:52:49. The location was identified as Taylor's residence 8401 South Dixie Highway. Additional information provided identified Taylor as "being distraught" as well as "been drinking" and that Taylor told his friend, Robert Van Norman (Robert), that Taylor could not use a gun because he was drinking and that "would be a felony". Miller advised he was "enroute".

At 00:55:40 W75 was informed that Taylor had been flagged as a suicidal male with



At 00:58:15 W70 informed W75 that WCSO could disregard due to Robert having open communication with Taylor. W75 acknowledged.

At 01:13:08 W70 and W75 were dispatched again to 8401 South Dixie again and informed

that Taylor had made comments that he was going to hurt himself prior to help arriving. Emergency Medical Services (EMS) were put on standby.

At 01:14:48 Dispatch informed W70 and W75 that Taylor does have firearms in the house and an expired Concealed Carried Weapon (CCW) permit.

At 01:18:32 W75 alerted W70 that Robert advised Taylor may be combative with law enforcement.

At 01:26:44 W75 advised he was on-scene at Taylor's residence.

At 01:29:39 W75 informed Dispatch that Taylor's friend Matt Patton (Patton) arrived at Taylor's residence.

At 01:30:46 W75 informed Dispatch that Taylor had a knife and W70 arrived on scene.

At 01:32:04 W70 advised he "had one at gunpoint".

At 01:33:50 W27 told W75 and W70 that if Taylor was only threatening himself, they should take additional cover and try to deescalate with Taylor's friend.

At 01:34:21 W27 advised Dispatch to notify command staff of the situation.

At 01:39:42 W27 stated he was on-scene. W70 informed W27 that Taylor was not responding well to him and that W27 needed to change locations with W70.

Between 01:39:42 and 02:35:07 multiple checkups were made by Dispatch. All were cleared as all units were still good at the scene.

At 02:35:07 W70 cleared the scene.

At 02:44:06 W27 informed Dispatch that Taylor had locked himself in the house again.

At 02:54:54 W75 indicated "shots fired".

At 02:56:22 W27 called for EMS to respond to the scene along with W70.

At 03:00:01 W27 called for an "air ambulance".

At 03:01:04 W27 requested administration be notified of an "officer involved shooting".

At 03:10:35 Additional WCSO Units advised they were in route to the location of the OICI.

At 03:20:23 W27 requested that someone from the detective section respond to the scene. W14, Lieutenant Rod Smith (Smith), advised he was heading to the location and to provide his contact to the Ohio Bureau of Criminal Investigation (BCI) agents responding.

At 03:26:28 Dispatch informed W14 that BCI had been contacted and would be reaching out to W14.

The remainder of the provided radio traffic did not contain any information that would be deemed important to the OICI investigation.
