**ACTION TAKEN:**

On 2/17/25, I, Officer Brown was working car 434. At approximately 0900 hours I responded to the area of 294 Ira Ave. for an officer involved shooting.

As I was responding to the scene I was directed to Kenmore Blvd/Lakeshore Blvd. to shut down traffic on Lakeshore Blvd. and to begin looking for shell casings from the suspect vehicle.

I blocked all traffic off at Kenmore Blvd./Lakeshore Blvd., using car 434. I then began walking northbound on Lakeshore Blvd. searching for shell casings. While searching I was notified by Capt. Brown that the gun involved was a revolver, so no casings would be found.

I then began conducting a door to door canvas on Lakeshore Blvd.:

**1266 Lakeshore** - no response, no visible cameras on the exterior of the property.

**348 Theodore** - Spoke to resident Vera Gordon [REDACTED] She was inside the house and says that she heard 4 shots fired, but did not see anything. She has no cameras on the property.

**345 Vincent** - No response, there is a doorbell camera here. It faces Vincent, unknown if it picked anything up.

**1282 Lakeshore** - A young lady walking in the area said that the resident here was at work. He does have 2 cameras on the property. One ring doorbell camera facing Lakeshore and one on the side door facing Beth St.. I spoke to the resident, Paul Allen, neither of the two cameras are currently working.

After being relieved from Kenmore/Lakeshore Blvd. I relieved truck 81 blocking Lakeshore Blvd at Lake St. I help this position until I was relieved by a 11-9 marked unit.
