JUDGMENT ENTRY

IN THE MATTER OF
 THE GUARDIANSHIP OF:
 JOSEPHINE GARY

This matter came before the Honorable Judge Anthony J. Russo on an Application for Appointment of Guardian of Alleged Incompetent, filed on April 28, 2021, and Prospective Guardian's Motion for a Psychological Examination or, in the Alternative, Appointing a Guardian ad Litem, filed on June 25, 2021, both by Attorney Bruce Taubman on behalf of Applicant, Constance Johnson. Further before the Court is a Motion for Appointment and Vacate Hearing, filed on May 19, 2021, by Attorney Taubman on behalf of Respondent, Josephine Gary.

A Magistrate's Decision was issued by Magistrate David M. Mills on the aforementioned motions on October 13, 2021. The Magistrate found that Respondent ("Respondent") is 107 years old and is currently residing in her home under the care of her step-granddaughter, Wilma Russell ("Ms. Russell"). ("Applicant") is represented by Attorney Bruce Taubman ("Attorney Taubman") that Ms. Gary has deteriorating mental capacity and is not competent to manage her responsibilities, risks, or benefits involved in decision making as a result of her age.

The Magistrate's Decision found that Ohio Rule of Surrogate Proceedings ("ORSP") applications for the appointment of a guardian on the grounds that Respondent is incompetent to manage her responsibilities, risks, or benefits involved in decision making as a result of her age.
