CONTRACT—STATE WITH ROBERT H. EVANS AND COMPANY, GENERAL WORK, MEDICAL COTTAGE, MASSILLON STATE HOSPITAL, MASSILLON, OHIO.

DEAR SIR: You have submitted for my approval the contract between the State of Ohio, acting through you as Director of the Department of Public Works for the Department of Public Welfare and the Robert H. Evans and Company, an Ohio Corporation, for the construction and completion of contract for General Work for a project known as Medical Cottage, Massillon State Hospital, Massillon, Ohio, as set forth in Item 1, General Contract for Medical Cottage (exclusive of Elevator) of the Form of Proposal dated April 6, 1939. This contract calls for an expenditure of \$133,550.00.
