# Initial Narrative By Christopher Wade, 11/20/23 13:55

On 11/20/23 Ofc Dziak and I went to 5861 Ryan Rd for a welfare check. Dispatch advised that Victoria Carter called in talking about something was going on with her phone- there was a dot on her phone and she was scared to look outside her house. Victoria mentioned something about someone trying to kill her but did not elaborate. Victoria continued on about various things about her family leaving her etc. while we were en route.

Upon arrival, I spoke with Victoria outside of the front door. Victoria came out of the house and told me that she realized that she had been drugged. She told me she did not know where to begin. Victoria said that she let a bunch of criminals move into her house with her (they are no longer there). She told me she did not look them up before letting them move in with her temporarily. Victoria advised that these people were taking advantage of her because she is mentally ill. Victoria was talking very quickly and was difficult to understand at times. She told me she had a reminder on her phone that popped up and said "ak murders". Victoria said the reminder had a message attached to it that "kept going" and did not make sense to her. I asked if it was still on her phone and if I could look at it. Victoria told me no and said she was paranoid about the police and corruption.

Victoria told me she did not know what to do and she did not know if she should show me anything on her phone. She told me she opened her phone and there was a red dot in the street in front of her house and she was scared to look outside. I told her on my phone when I have the map open, it remembers my home since I drive there frequently and it was probably marking her home location. I could not be sure because she would not show me anything on her phone. I began to talk about how Victoria told me she was mentally ill and advised talking to her doctor or going to the hospital may be an option. Victoria told me she was planning on calling her doctor/counselor since they know her history. Victoria told me she is and started a with a way she was feeling lately and thought talking to the doctor would be a good idea. Victoria said she would call them and talk to them as well as her counselor. I advised Victoria to call us back if he was having any other issues

and we would try to help her the best we could. I again advised her to call her doctor and let them know how she has been feeling. We then cleared. I have completed a CIT referral form and submitted that.



On 1/3/24 I was dispatched to 5861 Ryan Rd for a welfare check. While en route, dispatchers advised that family members had not heard from Victoria Solkiewicz for several days. Myself and Ofc Baker arrived at the residence and observed several lights on inside the residence. We knocked several times and received no answer. We looked in the windows and did not see anyone present at the residence, and there was no car in the garage. I asked dispatchers to attempt to contact Victoria via phone. They called the phone number in her names file and the calls were repeatedly forwarded to voice mail. No contact was made with Victoria. END 257

# Supplemental Narrative By Raven Ory, 01/04/24 10:38

Follow Up/Negative Contact/Confirmed contact with someone else

On 1/4/23, Ofcs. Brink, Grice, and I responded to 5861 Ryan to attempt to follow up on this. A white Buick was parked in the driveway with fresh tracks in the snow. The vehicle returned to Victoria Solkiewicz. There was no answer at the door. I spoke with a neighbor who advised they typically avoid Victoria due to her numerous issues. They stated they had not seen her in quite a while. I contacted the initial caller, Germanico Sorgi, and he explained he had not heard from Victoria since New Year's Eve or prior - which is odd for Victoria. He noted that she has suicide or self harm. I then contacted David Kemp via telephone. He and Victoria share a child - which he has custody of. Kemp advised he had received a phone call and texts from Victoria at 0530 on 1/4/23. The texts stated police were at her house. Kemp noted that Victoria is paranoid of the police and believes they are all corrupt - which is why she was not answering the door for us. Kemp confirmed that Victoria is paranoid and has been known to use meth

however, he did not believe she has made any threats of harm to herself or others. We all cleared the scene at this point due to there not being enough to constitute us making entry into the home. I contacted Germanico and advised him reference the same. I encouraged Kemp and Germanico to contact MPD if anything else occurs. 219

# Initial Narrative By Erica Anderson, 01/09/24 13:28

On January 9, 2024, I was dispatched to 5861 Ryan Rd for a welfare check. Dispatch advised the complainant was the neighbor, who advised a female, identified as Victoria Carter was screaming all night. Sgt Ory, Ofc Brink and Ofc. Terwilliger also responded due to the address being familliar to MPD. MPD has made several attempts in recent days to conduct welfare checks on Victoria due to concerns about her mental health. Officers have been unable to locate Victoria to this point. I arrived first and observed the front door open of the house and Victoria standing in the storm door naked. Victoria opened the door yelled something and then closed the door. Victoria continued to ramble and talk through the window of the door, but she was unable to be understood. Victoria then shut the blinds and went into the house and I heard a door slam. I relayed the information to the arriving units. It was decided Victoria would need to be taken to Medina Hospital (MH) for a mental health evaluation due to her erratic nature and previous incidents. Ofc Terwilliger and I entered the house through an open back door and found Victoria locked inside a bathroom. I annouced our entrance, but Victoria did not respond for a while, and then she was still responding, but was unable to be understood. Sgt. Ory and Ofc. Brink arrived on scene at this point and Lafayette EMS was requested.

Sgt. Ory attempted to communicate with Victoria to no avail. Victoria demanded we tell her what her social security number and her legal were. Sgt. Ory provided Victoria with this information. Despite this, Victoria did not believe us to be the police and it was apparent she was not acting in a rational manner. Ofc. Brink was able to get into the bathroom, as myself and Ofc. Terwilliger controlled Victoria. She was still naked and screaming at us. Ofc Terwilliger held Victoria's arms behind her back while I handcuffed her. Once she was secured, a blanket was placed over her body and sandals on her feet. Ofc Terwilliger and I continued to have to force her out of the house to move Victoria to the ambulance waiting in the driveway. Victoria refused to move and continued to yell. Sgt. Ory, myslef and Ofc Terwilliger assisted Victoria into the squad. I rode with Lafayette EMS to Medina Hospital, where she was pink slipped. Victoria rambled and was unable to be talked to the entire time and the hospital was unable to reason with her as will. Victoria was left in the care of hospital staff. \*\*242\*\*

# Supplemental Narrative By James Terwilliger, 01/09/24 06:54

On 1/9/2024, Sgt. Ory, Ofc. Anderson, Ofc. Brink and I responded to 5861 Ryan Rd in reference to a requested welfare check of the occupant. En route, dispatch advised Jennifer Mccoy at 5868 Ryan Rd reported an unidentified person yelling from the house. This address is known to MPD as the home of Victoria Carter. MPD has made several attempts in recent days to conduct welfare checks on Victoria due to concerns about her mental health. Officers have been unable to locate Victoria to this point. Ofc. Anderson arrived on scene and advised Victoria was standing nude in front of the house, rambling incoherently. When she saw Ofc. Anderson, she went inside the house, closed the door and the curtains. I arrived on scene at this time. It was decided Victoria would need to be taken to Medina Hospital (MH) for a mental health evaluation due to her erratic nature and previous incidents. Ofc. Anderson and I entered the house through an open back door and found Victoria locked inside a bathroom. Ofc. Anderson called to Victoria, identifying us as law enforcement. Victoria replied incoherently. She did believe us to be police officers. Sgt. Ory and Ofc. Brink arrived on scene at this point and Lafayette EMS was requested.

Sgt. Ory attempted to communicate with Victoria to no avail. Victoria demanded we tell her what her social security number and her legal were. Sgt. Ory provided Victoria with this information. Despite this, Victoria did not believe us to be the police and it was apparent she was not acting in a rational manner. Lafayette EMS arrived and were briefed on the circumstances by Sgt. Ory. After numerous requests to comply with our orders to exit the bathroom, Victoria continued to ramble on. Ofc. Brink forced the door open at which time Ofc. Anderson and I entered the bathroom and took control of Victoria. She was still naked and screaming at us. I held Victoria's arms behind her back while Ofc. Anderson handcuffed her. Once she was secured, a blanket was placed over her body and sandals on her feet. Ofc. Anderson and I attempted to move Victoria to the ambulance waiting in the driveway. Victoria refused to move and continued to yell. Sgt. Ory and I were able to lift Victoria from the ground and move her to the ambulance. Victoria was placed in the rear compartment and joined by Ofc. Anderson. Sgt. Ory and Ofc. Anderson accompanied Lafayette EMS to MH, while Ofc. Brink and I cleared the scene.
