On Monday, October 16, 2023, Crime Scene Technician Michael Rostocil responded to 4055 Highlander Pkwy, Richfield, Ohio (Ohio BCI – Richfield Office) to photograph and package evidence regarding an officer-involved critical incident.

CST Rostocil removed Items #11-12 from the drying room and photographed the overall condition of them (Figures #1-7). Item #11 was a black Hanes brand tank top, XL. It was bloodstained and cut and had a red rope/tie around the straps. There was a defect in the front right chest area and a defect in the right back area. Item #12 was a gray MISSION RIDGE brand hooded and zippered jacket, size 2XL. It was bloodstained and cut on the right side. There were defects in the upper left sleeve. CST Rostocil packaged Items #11-12 separately and placed them into temporary evidence locker #4.
