#### Allegation

On March 05, 2021, the Columbus Division of Police (CPD) requested the Bureau of Criminal Investigation (BCI) to respond to an Officer-Involved Critical Incident (OICI) that occurred on Interstate 270 Northbound on Big Walnut Creek Bridge, Columbus, Ohio. Andrew Teague (Teague) was wanted on a Felonious Assault warrant and fled from multiple jurisdictions in a vehicle pursuit. The pursuit culminated with Teague driving the wrong way into oncoming traffic on I270 causing several crashes. Law enforcement Officers from CPD and Franklin County Sheriff's Office encountered Teague and ultimately discharged their firearms striking him. Teague died as a result of those gunshot wounds. BCI Crime Scene and Special Investigation Agents were assigned the OICI investigation. CPD will handle the traffic investigation and all other related allegations concerning Teague.
