Narrative:

On January 9, 2023, at approximately 1616 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) received medical records from Cleveland Clinic, Akron General Hospital for care provided to Zachary Zoran (Zoran). The records were provided pursuant to a search warrant and were provided via a secure online portal maintained by Cleveland Clinic. The records consisted of two files.

The first file, titled, 2023-01-09 Akron General Hospital Zachary Zoran Certification, is a single-page PDF document detailing the authenticity of the second document.

The second file, titled, 2023-01-09 Akron General Hospital EMR Report, is a 105-page PDF document detailing records of patient treatment received by Zoran on December 24, 2022.

The medical records documented the extent and nature of care received by Zoran at the time he was taken to the hospital under a psychological hold referral (pink slip) on December 24, 2022. The records further provided details regarding Zoran's evaluation, treatment, toxicology, medications administered and discharge instructions.

SA Valente reviewed the records and noted the following:

Zoran was admitted on 12/24/2022, at 1215 hours.


Under the *Reason for Visit* heading, the document includes the following notation:

Hospital staff placed ankle and wrist restraints on Zoran upon his arrival, noting *Combative Behavior; Risk of Harm to Self; Risk of Harm to Others*.
