Title: Assault on Police Officer / On Duty / Abated by Death / Foreign Agency / Police Intervention / Gun Confiscation / F.I.T. #22-17

Sir,
 On Monday September 5, 2022 while off duty, I received a telephone notification and text message that Crime Scene Unit personnel were requested to respond to the address of 4562 West 174th in connection with a full (F.I.T.) call up involving a (CMHA) police officer. I contacted Sgt. Rini #9051 of the Crime Scene Unit and was instructed to respond to Metro Health Hospital (ER), and confer with Det. Powell #2062 from the Homicide Unit. Upon arrival at 0230 hrs, I conferred with Det. Powell #2062, Sgt. Matson #9261 (Internal Affairs Unit), and (CMHA) Police Officer Desmond Ragland #57, after receiving the required information photographs were taken documenting Officer's Desmond Ragland #57 overall appearance and wounds.

 A total of 24 color images were taken showing general overviews of Officer Ragland #57 documenting his overall appearance in uniform, and the locations of his wounds. The following images were taken noting wounds to the index finger of the left hand, swelling and discoloration to the right side of the face, and bruising below the left eye. Officer Ragland stated the bruising below the left eye didn't occur during the physical attack. Additional images were taken of the pocket knife attached to the lower right pants pocket of Officer Ragland.
