**Narrative:**

On June 16, 2024, Special Agent (SA) Josh Rammel (Rammel) and SA Jason Snyder (Snyder) attempted to make contact with Sheila Long (Long) at her address 1704 Clough Street #106, Bowling Green, Ohio. The contact attempt was made in regard the Officer Involved Critical Incident (OICI) involving the Wood County Sheriff's Office (WCSO) and deceased individual George Eric Taylor (Eric).

Prior to the contact attempt SA Rammel spoke with Eric's wife Jessica Taylor (Jessica) and was informed that she did not have any contact information for Eric's family due to Jessica and Eric not having been married for a long period.

SA Rammel was provided with Long's address by the WCSO and informed that she was the closest relative to Eric who contact information was available for.

SA Rammel and SA Snyder rang Long's doorbell several times but were unable to establish contact. As SA Rammel and SA Snyder were leaving the residence, an individual identifying herself as Long's friend approached SA Rammel and informed him that she could call Long if SA Rammel would like her to. The friend informed SA Rammel that Long had left with someone from the WCSO and that Long had already been notified about Eric's death.

Long was contacted at [REDACTED]. Long told SA Rammel that she was currently with the WCSO heading towards her mother's residence in order to notify her mother of Eric's death.

Long was able to provide SA Rammel with the contact information for Christina Taylor (Christina). Christina was identified as Eric's ex-wife, who currently lives in North Carolina. Christina and Eric have two adult children.

SA Rammel expressed his sympathy to Long for her loss and provided his contact information
