Narrative:

On Friday, May 23, 2025, at 0914 hours, Ohio Bureau of Criminal Investigation (BCI) Administrative Professional Betsy Turney sent a copy of this case file to Ohio Attorney General's Office (AGO) Special Prosecutions Section via Matrix Exchange. At 1120 hours, Special Agent (SA) Jon Lieber (Lieber) sent the Axon Justice case file to AGO Paralegal Michael Perez (Perez) via Axon share download link.
