## Narrative:

On Monday, July 22, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) received requested records and recordings from Medina County Sheriff's Office (MCSO) Captain Eric Bors. SA Tingley had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date and time period: July 17, 2024 at 1803 hours, until July 17, 2024 at 1820 hours.




