GENTLEMEN:—The transcript of the proceedings relative to the above issue of bonds discloses that notice of election was published for four consecutive weeks on the same day of each week, commencing on October 26, 1929, and that the issue was submitted to the electors on the 5th day of November, 1929. Section 2293-21, General Code, provides that "notice of election shall be published in one or

more newspapers of general circulation in the subdivision once a week for four consecutive weeks prior thereto." This office has consistently held that the provisions of this section require the publication of notice of election to be throughout or during the continuance of four consecutive weeks prior thereto. *State of Ohio vs. Kuhner and King*, 107 O. S. 406. It accordingly follows that the date of first publication of this notice must be twenty-eight days before the election.

In view of the failure to comply with the provisions of Section 2293-21, I am compelled to advise you not to purchase these bonds.
