**Narrative:**

On July 16, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jesse Bynum (Bynum) reviewed the following items related to the May 3, 2024, officer-involved critical incident in Tuscarawas County, Ohio:

- o Ohio State Highway Patrol (OSHP) Incident Recall Report.
- o Tuscarawas County Sheriff's Office (TCSO) Dispatch Telephone Calls
- o Audio recorded radio traffic and data from OSHP and TCSO

The documents and recordings were provided on 5/3/2024 from Ohio State Highway Patrol Sergeant Shawn Aller (Allar). The recorded radio traffic and dispatch calls have been stored in the BCI SIU case file as Reference Item E. The OSHP and TCSO CAD reports have been uploaded to Matrix and attached to this report. SA Bynum reviewed the provided files and recordings and noted the following:

The file titled "Shooting 5.3.2024 - Radio Traffic (1048341-1049881) (1)" was one video WMA file. The recording was 38 minutes and 42 seconds in length and contained radio communications between the OSHP Dispatchers and the responding OSHP Troopers.

The file titled "OSHP- Dispatch Log" was one PDF file. The PDF was 33 pages in length and contained call statuses input by OSHP Dispatchers during the incident.

The folder titled “CFS24-16804 phone calls” contained four individual recorded telephone calls and the corresponding Call Detail Record (CDR) data. Each telephone call was stored in a separate audio WAV file and was titled with a date and time of the call. The folder also contained a Comma Separated Values (CSV) File for each call with the corresponding date and time as the title.

The folder titled “CFS24-16804 radio 79 TCSO” contained 142 individual radio transmissions. Each transmission was stored in a separate audio WAV file and was titled with the date and time of the transmission, the channel number, and the call transmission number. They appeared to be in sequential order descending from the most current beginning with “2024-05-03\_06.26.04\_Ch40273904” and the oldest beginning with “2024-05-03\_02.46.01\_Ch40273416”. The folder also contained a text document titled “Exported MetaData2024-05-03 at 02.46.01” which contained identifying data for the recorded radio transmissions. SA Bynum reviewed each of the recorded radio transmissions and the data. The table below contains the radio data and content of the radio traffic for the transmissions believed to be most relevant to this investigation.

Transmissions not included in the table contained radio traffic from dispatchers, numerous responding officers, and supervisors. The content of those radio transmissions included information related to responding back up officers, management of the incident and identifying the agency with jurisdiction.
