Narrative:

On April 2, 2025, the Ohio State Highway Patrol (OSHP) requested the Ohio Bureau of Criminal Investigation (BCI), to assist with an Officer-Involved Critical Incident that occurred at I-275 near SR-32, in Clermont County, Ohio.

As part of the investigation, Criminal Intelligence Analyst Emily Kreager and BCI Special Agent Lauren Frazier conducted a search utilizing Flock Safety to determine vehicle location history, associated with the involved-subject, Kelsey Hildal. Flock Safety is a License Plate Recognition (LPR) software that captures vehicle characteristics and license plates. Data collected by the cameras is stored by Flock and deleted every 30 days.

On April 4, 2025, Ohio BCI Analyst Emily Kreager ran a Flock search reference Hildal's registered vehicle, a 2010 red Ford Escape with Ohio license plate# JVV3278. The report was run for March 4, 2025, through April 5, 2025. The records included data from March 5, 2025, through April 2, 2025.

On April 9, 2025, SA Frazier ran an additional Flock search reference Hildal's registered vehicle. The records included data from March 13, 2025, through April 2, 2025. SA Frazier downloaded the Flock Image results, which also captured results from March 13, 2025, through April 2, 2025.

Within the records, there were numerous Flock locations recorded on the date of the incident, April 1, 2025. The following table documents the consolidated locations where Hildal's vehicle was captured on Flock:
