This lease is for a term of two (2) years, beginning on the first day of January, 1929, and ending on the 31st day of December, 1930, by the terms of which the State will be required to pay the sum of one hundred and sixty-five dollars (\$165.00) per month on the first day of each and every month, in advance.

Lease from the Masonic Temple Company of Zanesville, Ohio, for Rooms 419 and 420 on the fourth floor of the Masonic Temple Building, Zanesville, Ohio. This lease is for a term of two (2) years, beginning on the first day of January, 1929, and ending on the 31st day of December, 1930, by the terms of which the State will be required to pay five hundred and forty dollars (\$540.00) per year in equal monthly installments on the last day of each and every month during said term.

Lease from the L-T Building Company, of Lima, Ohio, for Rooms 822 and 823 on the eighth floor of lessor's building located in the public square at West Market Street in the city of Lima, Ohio. This lease is for a term of two (2) years, beginning on the first day of January, 1929, and ending on the last day of December, 1930, by the terms of which the State will be required to pay forty-eight dollars (\$48.00) per month on the first day of each and every month, in advance.

You have submitted encumbrance estimates which contain the certificate of the Director of Finance to the effect that funds are available for the payment of said rentals for the period through June 30, 1929. In each instance where an individual is not leasing the premises proper evidence of authority has been furnished indicating the right of the persons executing said leases to execute them.
