**Narrative:**

On July 9, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent Kyle Douglass (SA Douglass) reviewed the "Computer Aided Dispatch" (CAD) report, dispatch radio traffic audio, and 911 emergency call audio received from Columbus Division of Police (CPD) Sergeant Terry McConnell (Sgt. McConnell). This documentation was requested by BCI in order to investigate an Officer-Involved Critical Incident (OICI) which occurred on May 11, 2024, near 4738 McAllister Avenue in Columbus, OH. It was reported that CPD officers were called to a domestic disturbance involving an armed individual who had allegedly discharged a firearm when they became involved in an encounter with Corey Roach (Roach). During the encounter, a CPD officer discharged his duty weapon. Roach was transported to Mount Carmel hospital with alleged gunshot wounds, where he was pronounced deceased.

### 911 Emergency Calls

Five 911 emergency calls were reviewed, SA Douglass noted the following:

- 2024-05-11\_19.08.04\_Ch48918565.wav – Unknown caller advised he and his cousin were shot at by "a male who was beating on his girl" near 4738 McAllister Avenue. Caller provided a description of the male's clothing. Possible gunshots can be heard in the background.
- 2024-05-11\_19.07.46\_Ch48918587.wav – Unknown caller stated, "I would like to report some shots fired," and explained there was an domestic altercation and an individual was actively firing a gun in the area. Caller reported the shooter to be a black male and stated he believed someone had been shot. Caller provided a description of the male's clothing.
- 2024-05-11\_19.11.34\_Ch48918705.wav – Caller identified herself as Patricia Seymour from 1115 Lockwood Road, reported hearing gunshots and seeing someone running down the street on her security cameras. Caller provides a physical description of the running male. Caller reported actively hearing gunshots during 911 call.
- 2024-05-11\_19.13.26\_Ch48918715.wav – Female caller w/ Hispanic accent reported someone shooting in the street on Lockwood Road.
- 2024-05-11\_19.08.53\_Ch48918639.wav – Caller reported gunshots and seeing someone running down the street on Lockwood Road. Caller provided a physical description of the running male. Caller reported actively hearing gunshots and people screaming during 911 call.

### Radio Traffic Recordings

One folder titled "Z2 Radio Traffic [REDACTED]" containing audio files from CPD Zone 2 Channel 77 was provided. A total of 1410 audio files related to the incident were provided and are available via Axon/Evidence.com for review. A majority of the radio traffic is related to scene location and logistics, officer support and response to secure the scene.

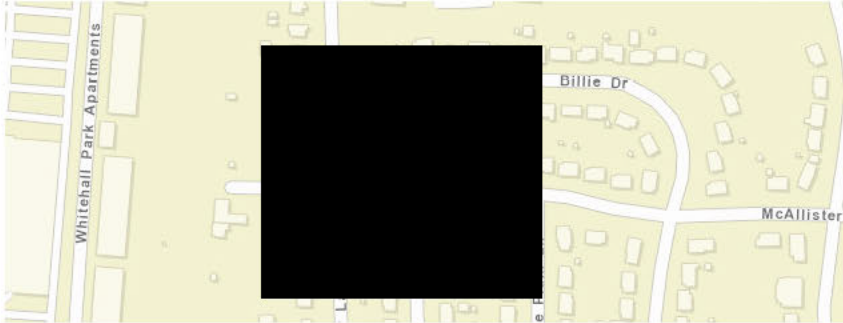
