**Narrative:**

On May 6, 2024 Ohio Bureau of Criminal Investigation (BCI) Special Agent James Poole (SA Poole) received copies of the medical records for Santigo Alfaramunoz (Alfaramunoz), from the Mt. Carmel Medical Center (Mt. Carmel). The medical records were obtained via an Investigative Subpoena from SA Poole through the Franklin County Municipal Court. These records are regarding the injuries of Alfaramunoz as a potential result of an Officer-Involved Critical Incident which occurred on April 19, 2024. A copy of these records will be maintained within the case file. Please refer to the records for specific details.

On May 28, 2024, SA Poole reviewed the medical records for Alfaramunoz. Alfaramunoz was transported via Emergency Medic 152 to Mt. Carmel East on April 19, 2024 at 0233 hours, with a traumatic gunshot wound to the head. The records indicate, [REDACTED]

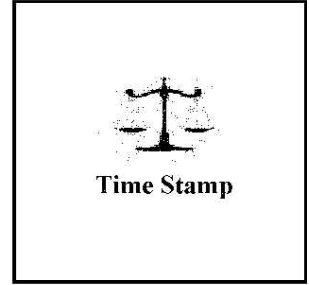
