Narrative:

On May 27, 2022, at 1435 hours, Ohio Bureau of Criminal Investigation Special Agent Steven Seitzman conducted an interview with Dan Mack (Asst. Chief Mack), Miami Township Assistant Fire Chief. Asst. Chief Mack responded to 947 SR-28 Business (Berry Lane Apartments) on May 20, 2022, at approximately 1700 hours. He was dispatched to a patient with a gunshot wound. While he was responding, he learned it was an officer-involved shooting.

Asst. Chief Mack responded directly to the scene, as he was notified the scene was safe. He arrived immediately after the ambulance, which was already in the area. He was notified that Air Care was placed on standby. He was notified by paramedics that Air Care would in fact be needed. The patient was later identified as Camille Artice Weems (Ms. Weems). Paramedics performed bleeding control and other advanced life support procedures. Ms. Weems was loaded into an ambulance and transported to the Eastside Christian Church, located at 5874 Montclair Boulevard, in Miami Township. The medic crew waited in the parking lot for the Air Care crew to arrive.

Asst. Chief Mack advised Ms. Weems did not say anything during the entirety of patient care. During transport to the church parking lot, Ms. Weems lost all pulses and CPR was initiated. Once the Air Care crew arrived, it was determined Ms. Weems was deceased and would not be flown to a hospital.

The medic crew kept Ms. Weems in the ambulance and waited for the Clermont County Coroner's Office representative to arrive. Ms. Weems was transferred from the ambulance to the coroner's vehicle.

The interview was concluded at 1446 hours. The audio recording is attached below. Asst. Chief Mack later provided SA Seitzman with the run report, as well as prior run reports involving Ms.
