NARRATIVE

FELONIOUS ASSAULT / IMPROPER DISCHARGE / NAMED SUSPECT
2024-015839

On Wednesday, January 17th, 2024, while assigned to 4A38, P.O. Reynolds #1236 and I received a radio broadcast to respond to 7702 Canton avenue for a code one shot spotter alert at 1849 hours. This is in connection with RMS (2024-016109), (2024-015952), (2024-016108) and (2024-011613). We were assisted by members of 4A31 P.O. Ayers #635 & P.O. Lyberger #1547, members of 4A32 P.O. Kane #997 & P.O. McCartney #820, members of 4A35, P.O. Blocton #32 & P.O. Morrison #1017, member of 4S33, Sgt. Wills #9321. We were also assisted from members of the 2nd, 3rd and 5th district, along with various support units. Below are the details of the incident.

Upon our arrival, we were touring Spafford road traveling in a S/B direction in Z/C 422. As we were touring the area multiple shots were heard coming from the S/B direction. I had advised CCS that shots were heard in the area. As we approached the intersection of Canton avenue and Spafford road, I observed a house located on the Southernwestern corner. This house was playing extremely loud music and had a green neon sign in the the window stating "fair warning today will be the end". We then had met with 4S33 Sgt. Wills #9321. Dispatch had then advised that they recieved a call from [REDACTED] (24-016109) advising that his neighbor was shooting multiple rounds. As were were trying to identify where the shots came from multiple shots were heard within close proximity.

We then proceeded to take cover near the intersection of E75th street and Canton avenue, and requested additional units to respond. Swat along with various other support units had arrived on scene and attempted to make contact with the the individual inside, later identified as Robert Perkins (SUSPECT). Cleveland Swat and County Sheriffs department had arrived on scene. Robert had refused multiple request from the Swat teams to come to the door. Robert began playing loud music and saying various phrases into a microphone he had contacted to a loud speaker. Robert was stating he was ready to die and there is no good people left in the world. At approximately 02010 hours, Robert had begun to fire an assault rifle from his home. Robert had fired multiple rounds causing the officers on scene to take additional coverage.

Robert had also to fired his assault riffle at the Swat team Bearcat vehicles, which multiple officers were inside the vehicles at the time in front of the home. After a brief period of time, Swat had made entry into the home and began to render aid. Medic #11 had arrived on scene to convey Robert to Metro Hospital for his injuries. Dr. Claridg had called TOD at 0306 hours.
