RE: Freedom to choose whether to participate in a labor organization as a condition of employment

Dear Mr. Thompson:

In accordance with the provisions of R.C. 3519.01(A), on November 10, 2011, I received a written petition proposing to add the above-named Amendment to the Ohio Constitution, and a summary of the measure to be referred. Pursuant to R.C. 3519.01(A), the Attorney General must examine the summary and determine whether it is a fair and truthful statement of the measure to be referred. If I conclude that the summary is fair and truthful, I must certify that fact to the Secretary of State within ten days of receiving it. In this instance, the tenth day falls on Sunday, November 20, 2011.

After reviewing the submission, I have concluded that I am unable to certify the summary as written. Section 22(F) of the of the proposed amendment provides that "[a]ny person, directly or indirectly affected or threatened with any harm by a violation of this section, may bring a civil or equitable action to enforce this section, and upon prevailing shall be entitled to injunctive relief, reasonable attorney fees, costs, and other damages."

A person reading the summary to gain an understanding of the proposed amendment would likely assume that a person directly affected by a violation of this section would have some sort of legal recourse to enforce compliance. However, it is unlikely that a person reading the summary would anticipate that a person only "indirectly affected" by a violation of this section could also move to enforce this section. Additionally, the summary makes no mention of a prevailing party's entitlement to reasonable attorney fees, costs, and other damages. In order for the summary to be fair and truthful, a reference to these provisions of the proposed amendment should be included in the summary language.
