Narrative:

Over a period of several months, Ohio Bureau of Criminal Identification and Investigation (BCI) Special Agent Ryan Scheiderer (SA Scheiderer) and Special Agent Kyle Douglass made numerous unsuccessful attempts to collect any video recordings from the rental office for Bexley Commons located at 3090 E. Livingston Road that may have captured the events of the July 08, 2023, shooting incident between Antwan Lindsey (Lindsey) and officers from the Columbus Division of Police (CPD) and **Example 10** for the Franklin County Sheriff's Office. Lindsey was fatally shot by officers during that incident inside an apartment building located at 3110 E. Livingston Avenue.

While on scene of the shooting incident, agents observed interior and exterior cameras present at 3110 E. Livingston Avenue. SA Scheiderer called the Emergency telephone number (614–237–6405) for the apartment building and did not receive an answer and the mailbox was full. On July 11, 2023, SA Scheiderer called the same number and left a detailed voicemail requesting a callback. That voicemail went unanswered.

On July 12, 2023, at approximately 1015 hours, SA Scheiderer and SA Douglass went to the rental office and made contact with maintenance worker, James E. Saunders (Saunders), who advised agents that the cameras for 3110 E. Livingston Avenue do not work, but the cameras on 309 E. Livingstone Avenue do work and may have captured some of the events of the July 8th shooting incident. Saunders provided agents with the contact information for Hanan Hamzie (Hamzie), Community Manager for the apartment buildings.

On July 12, 2023, at approximately 1425 hours, SA Douglass sent Hamzie an email requesting access to their video recordings related to the July 8th shooting incident. That email went unanswered and on July 27, 2023, SA Scheiderer sent Hamzie a follow up email requesting a status update. On July 28th Hamzie replied to SA Scheiderer's email stating the videos were burned to a disk and available to agents. SA Scheiderer made several attempts to obtain the

disk, but never found anyone at the rental office. On September 08, 2023, SA Scheiderer and Special Agent Andrew Russell (SA Russell) made contact with Hamzie at the rental office and she provided SA Scheiderer a USB thumb drive that was alleged to contain the requested recordings. Hamzie also reported that "Detective Brown" from CPD had already obtained the videos. SA Scheiderer later checked the USB thumb drive and there weren't any files located on it. SA Scheiderer contacted CPD Sergeant Terry McConnell (Sgt. McConnell) to inquire why "Detective Brown" would have retrieved video form the incident location and learned there is no "Detective Brown" and no one from CPD obtained any video from the incident location.

On September 08, 2023, at approximately 1408 hours, SA Scheiderer emailed Hamzie and advised her the USB thumb drive she provided agents was blank. Hamzie replied on September 08, 2023, and stated she had copies that were available to be picked up. SA Scheiderer stopped at the rental office on October 02, 2023, and it was locked up and no one was present. SA Scheiderer sent an email to Hamzie advising her he had been there, nobody was present, and asked for the next time she would be working. That email went unanswered. SA Scheiderer has stopped at the rental office numerous times and each time it is locked and no one is present. No one answers the telephone number for Bexley Commons or responds to voicemails that are left. SA Scheiderer's last email dated December 18, 2023, to Hamzie went unanswered. All attempts to obtain any video recordings from Bexley Commons have been exhausted and due to the lack of cooperation from the employees, SA Scheiderer can't confirm video(s) ever existed.
