This caller believed that the suicidal subject was going to the attic to hang himself.

Upon arrival you found this residence to be an upstairs/downstairs apartment. After receiving no answer at the first floor you located a second door that led to the upstairs apartment.

You made entry into the home under these exigent circumstances and began to check the rooms on the second floor before making your way to the attic where you heard a loud moan and gasp.

You located the suicidal subject and found him in the process of hanging himself with a coaxial cable. You moved quickly to cut the cable and lower the subject to the floor.

EMS was summoned and transported the subject to ACH where he was evaluated and treated.

Without a doubt this subject would have successfully taken his own life on this evening without your truly heroic response.
