CONTRACT—STATE WITH THE STERLING AND WELCH COMPANY. FURNITURE AND FURNISHINGS, WOMEN'S PHYSICAL EDUCATION BUILDING AND NATATORIUM, BOWLING GREEN STATE UNIVERSITY, BOWLING GREEN.

DEAR SIR: You have submitted for my examination and approval a contract by and between The State of Ohio acting through you as Director of the Department of Public Works for the Board of Trustees of Bowling Green State University, Bowling Green, Ohio, and The Sterling and Welch Company, an Ohio Corporation, for the construction and completion of Contract for Furniture and Furnishings for a project known as Landscaping, Equipment, Bronze Tablets, Painting and Acoustic Treatment, Women's Physical Education Building and Natatorium, Bowling Green State University, Bowling Green, Ohio, as set forth in Item 1. Contract for Group A—Furniture and Furnishings of the Form of Proposal dated October 13, 1939, all according to plans and Specifications, which Plans, Specifications and Proposal are made a part of this Contract. The contract requires an expenditure of \$3,525.00.

You have submitted the following papers in this connection: Form of Proposal containing the contract bond signed by United States Guarantee Company; its power of attorney for the signer and its certificate of compliance with the insurance laws of Ohio relating to surety companies; certificate of availability of funds; division of contract; estimate of cost; notice to bidders; proof of publication; Workmen's Compensation Certificate indicating a compliance with the laws of Ohio relating to Workmen's Compensation; State Architect's recommendation; resolution of Board of Trustees of Bowling Green State University joining in the State Architect's recommendations; approval of P. W. A.; tabulation of bids; letter from the Auditor of State showing that all papers necessary for this project are on file in his office.
