Narrative:

On January 25, 2022, at 1100 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong (Armstrong) returned four items of evidence to the office of Blakemore Meeker & Bowler Co.
