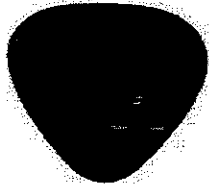

DATE:

Ptl Sizemore made a traffic stop at the Filling Station after observing JLZ8206 go left of center. Ptl Sizemore made contact with [redacted] Miranda Lynn Linton S15 out of Butler County [redacted] Shawn Norman S15 out of JPD, [redacted] William Beach S15 JCSO, and Ashly Hill. Shortly after start of the stop Ptl Thompson arrived on scene and stood by as Ptl Sizemore ran K9 around the vehicle. Ptl Sizemore advised positive indication on passenger rear door. Ptl Thompson advised Ptl Sizemore was in a foot pursuit with William Beach. Ptl Sizemore was able to catch Beach and place him into custody shortly after the pursuit began. Ptl Payne, Sgt Kisor and Ptl Bock arrived on scene to assist. I was advised by Ptl Thompson that Beach had struck Ptl Sizemore after a brief altercation on the ground between Ptl Sizemore and William Beach. Ptl Sizemore issued a citation to Ashly Hill and William Beach and Shawn Norman were transported to JPD for processing.

On 08/22/2022 I was actively patrolling the area of West Main Street near the intersection of West street when I observed a black Chevy SUV (GTN7067) traveling towards Bridge Street. I observed the vehicle swerve over the double yellow line. I then proceeded to get behind the vehicle and that is when the vehicle went left of center once again. I initiated at traffic stop at the Filling Station (Bridge/Main Street). I then made a drivers side approach to the vehicle where I spoke with the driver, Ashly Hill. I advised Ashley of the reason for the stop. Ashly stated that she knew she went left of center a couple of times she said her passenger was distracting her. I requested and received relevant documents from Ashly. The front passenger also gave me her license as well. I then looked in the rear of the vehicle, which has third row seating, and observed a male right behind the drivers seat. The rest of the middle section was empty, however, another male was sitting on the 3rd row seat by himself. Through my drug interdiction training and experience, criminal indicators were suspected. Patrolman Thompson arrived on scene to assist and was at the passenger side front window/door. I then advised Ashley that I was going to run my police K9 around the vehicle. I then proceeded to ask Ashly if there was anything illegal within the vehicle. Ashly stated that there could possibly be a "joint". I then proceeded to my patrol cruiser while Patrolman Thompson stayed at the vehicle. I then proceeded to get K9 Garka out of the vehicle. K9 Garka immediately indicated on the rear passenger door. I then advised dispatch as well as Patrolman Thompson that there was a positive identification. I started with the male that was sitting in the rear behind the driver, identified as Shawn Norman. While very briefly speaking with Shawn and him stating that he possibly had an active arrest warrant while standing at the rear of the suspect vehicle, the male that was sitting on the 3rd row seat exits the suspect vehicle. Patrolman Thompson advised the male to stay and get back in the vehicle. The suspect male then immediately started running through the parking lot of the Filling Station. I chased after him advising him to stop, however, the suspect male continued to run away. We then ran to the roadway on Bridge Street where I took down the male in the middle of the road. The male then attempted to get up and that is when I got on top of him in attempt to detain him. However, the male hit me in the face with his hand twice as he is trying to flee from the arrest. The male continued to resist. Sgt Kisor and Patrolman Payne arrived at my location where the suspect, identified as William Beach, was placed into custody and put inside Patrolman Payne's cruiser. While walking back to the scene, I noticed that I was bleeding from my forearm and had ripped my knee section on my pants. Dispatch confirmed a warrant on Shawn Norman through the Jackson Police Department. A search of the vehicle was then conducted revealing drug paraphernalia in the form of a drug pipe with residue. That evidence was collected. A citation was given to Ashly for left of center. All units then cleared the scene. I transported Shawn and Patrolman Payne transported William to the Jackson Police Department where they were placed within the holding cell. William was asked if he needed any medical attention, however, William refused. Charges were filed on William for resisting arrest, obstruction and felonious assault on a peace officer. Shawn was bonded out on his active arrest warrant. I was later advised that the Jackson County Correctional Facility wanted William medically cleared at Holzer due to William claiming injury. Units then took him to Holzer where he was cleared shortly after. He was then transported to JCCF and held.

I made contact with the Filling Station for video footage. They advised that the footage has to be done by the manager, however he would not be in until 08/23/2022.

Karissa Haynes will attempt to get footage and this will be added to the case should JPD be able to obtain the footage.
