DEAR SIR:—You have submitted for my approval a contract between the State of Ohio, acting by the Adjutant General, and F. A. Garner, of Lynchburg, Ohio. This contract covers the construction and completion of a State Armory to be erected in the city of Lima, Ohio, and calls for an expenditure of eighty-four thousand six hundred and forty-nine dollars (\$84,649.00).

You have submitted the certificate of the Director of Finance to the effect that there are unencumbered balances legally appropriated in a sum sufficient to cover the obligations of the contract. There has further been submitted a contract bond upon which J. M. Garrison, L. W. Dewey, Joseph C. Dewey and Raymond B. Dewey appear as sureties, sufficient to cover the amount of the contract.

You have further submitted evidence indicating that plans were properly prepared and approved, notice to bidders was properly given, bids tabulated as required by law and the contract duly awarded. Also it appears that the laws relating to the workmen's compensation have been complied with.
