Narrative:

On May 3, 2024, Special Agent Jason Snyder (SA Snyder), with the Ohio Attorney General's Office, Bureau of Criminal Investigation (BCI), received a pair of sunglasses from Mercy Health Hospital, Protective Services Department, Tiffin, Ohio.

On this day, SA Snyder was assisting the Special Investigation Unit (SIU), in Tiffin Ohio. SIU was currently investigating an Officer Involved Critical Incident (OICI). While assisting with the investigation, SA Snyder was asked to retrieve a pair of sunglasses from the Protective Services Department, at Mercy Health, Tiffin Hospital.

When SA Snyder arrived, he was met by Officer Chad Kessler (Kessler). Officer Kessler provided SA Snyder with a pair of Oakley, Steel plate, Glasses. SA Snyder provided Officer. Kessler with an Inventory/Receipt document for the glasses. Officer Kessler reviewed the document and signed it, stating that he was releasing the glasses to SA Snyder. (See attached receipt form).

The glasses are believed to be the property of Blake Fleure (Blake). Blake was involved in the OICI and these glasses were secured by Mercy Health Protective Services, while he was in their care.
