DEAR SIR:—You have submitted for my examination the following state game refuge land leases, in duplicate, made to the State of Ohio, to wit:

1. Lease No. 2196 covering a certain tract of 206 acres in the Village of Boston Heights, Boston Township, Summit County, Ohio, executed by the Akron Council of Girl Scouts of Akron, Ohio, which tract of land is more particularly described in said lease.

2. Lease No. 2197 covering five certain parcels of land in Farmer Township, Defiance County, Ohio, executed by D. Frank Bricker and Minnie A. Bricker, which several parcels of land are more particularly described in said lease.

Upon examination of said leases, I find the same to have been properly executed and acknowledged and, further finding that the same are in legal form, these leases and the duplicate copies thereof are hereby approved.

APPROVAL, LEASE TO RESERVOIR LAND IN FAIRFIELD COUNTY,
OHIO, FOR THE RIGHT TO OCCUPY AND USE FOR COTTAGE SITE
AND DOCKLANDING PURPOSES.

DEAR SIR:—This is to acknowledge the receipt of a recent communication over the signature of the chief of the bureau of inland lakes and parks in the conservation division of your department, submitting for my examination and approval a reservoir land lease in triplicate executed by the conservation commissioner to Carl E. Reed of Lancaster, Ohio. By this lease, which is one for the stated term of fifteen years and which provides for an annual rental of six dollars, payable in semiannual installments of three dollars each, there is leased and demised to Carl E. Reed the right to occupy and use for cottage site and dock-landing purposes, the waterfront and State land in the rear thereof, that lies in front of Lot No. 27 of Taylor's Sandy Beach Allotment of lands on the south shore of Buckeye Lake in Walnut Township, Fairfield County, Ohio, being fifty feet in length, more or less, measured along said waterfront.

Upon examination of this lease, I find that the same has been properly executed by the conservation commissioner and by the lessee above named.

Upon examination of the provisions of this lease and of the conditions and restrictions therein contained, I find that the same are in conformity with section 471, General Code, under the authority of which this lease is executed, and with other statutory enactments relating to leases of this kind.

I am accordingly approving this lease as to legality and form, as is evidenced by my approval endorsed upon the lease and upon the duplicate and triplicate copies thereof.
