Narrative:

On June 18, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Ryan Emahiser received subpoenaed medical records from Tiffin Mercy Hospital (TMH) for Blake Fleure (Blake). The records were received by mail, scanned in, are attached to this report and uploaded to this case file for review. Following the officer involved critical incident Blake was transported to TMH Emergency Room by Tiffin Fire and Rescue Department and treated for the injuries he sustained. The following is a review of the information contained in the records provided by TMH, and includes those items of relevance to this investigation.
