Narrative:

On Thursday, August 24, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Andrew Russell (SA Russell) and Detective Sargent Jim Marable (Marable) interviewed Chassity Edgerton (Edgerton), relative to the officer-involved shooting which took place on Wednesday, August 23, 2023, in the area of 1389 Marion Drive. The interview took place at 1875 Apt B, Oakland Place, Columbus Ohio. The purpose of the interview was to obtain all relevant information of the incident known or observed by this individual.

Edgerton stated that Jamie Overstreet (Overstreet) was her boyfriend and he called her at 11:08pm, on August 23rd and told her that "it's over". Edgerton added that Overstreet then said that Joelle (Overstreet's separated wife) called him and he went over to her place and she called the police on him. Edgerton added that Overstreet said that the police were chasing him, she could hear the sirens in the background, and that he was not going to stop. Edgerton said that Overstreet told her that he didn't want to do this anymore and that he would rather be dead than go to prison. Edgerton stated that she had witnessed a change in Overstreet's demeanor recently. Edgerton added that over the last two or three weeks, Overstreet had been talking about killing himself.

Edgerton stated that Overstreet would facetime his kids and Joelle every night before going to bed. Edgerton advised that Joelle would often call him and yell at him, but never witnessed Overstreet yell back. Edgerton added that Joelle constantly harassed Overstreet and used his kids against him. Edgerton stated that Overstreet knew he had warrants out for his arrest.

Edgerton stated that she never saw Overstreet with a firearm.
