**Narrative:**

On Tuesday, June 24, 2025, Ohio Bureau of Criminal Investigation (BCI) Special Agents John Tingley (Tingley) and Joseph Lamping (Lamping) contacted Strongsville Police Department (SPD) ██████████ the involved Officer in the Officer Involved Critical Incident, at the Incident Command Post which was situated near the intersection of Tiedeman Road and Southwood Drive, Brooklyn, Cuyahoga County, Ohio, 44144.

SA Tingley spoke with ██████████ and verified that ██████████ was a member of the SPD and the Southwest Enforcement Bureau Tactical Team. SA Tingley explained to ██████████ how the BCI investigation would proceed and that ██████████ would be contacted at a later time and given an opportunity to have an interview/give a statement. When asked where his equipment used in the incident was located at, ██████████ stated that he had left his helmet and rifle at the incident scene.

SA Lamping then escorted ██████████ back to the incident scene at the intersection of Tiedeman Road and the I-480 eastbound off ramp. Upon their arrival at that location, BCI SA Laurna McClintock took photographs of ██████████ from the front, back and each side, in the uniform he was wearing at the time of the incident.
