On Monday May 6th, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) John Tingley (Tingley) received requested records and recordings from the Tuscarawas County Sheriff's Department. SA Tingley had previously requested all dispatch records, audio recordings, mobile data terminal (MDT) communications, and any other dispatch/communications-related information for March 31, 2024. As a result of that request, the following items were received and reviewed. Below is a summary radio traffic deemed important by SA Najmulski.

**Radio Traffic Recordings:**

21:07:47 hours – ■■■ en route

21:09:34 hours – Unit ■■■ radioed to get units there now

21:09:53 hours – Dispatch replied that units were en route

21:10:00 hours – Unit ■■■ shouted (Out of breath and in distress), "Shots fired! He took my car! He's headed towards Philly".

21:10:07 hours – Dispatch replied, "Copy about your car and shots fired".

21:10:08 hours – Unit 38 radioed that she saw the subject coming down E. High Street and then said he lost sight. Unit 38 then said he got him again on Fourth Street.

21:10:44 hours – Unit ■■■ radioed, "I hit my finger".

21:10:54 hours – Unit 38 radioed she saw the subject on E. High Street.

21:11:17 hours – Unit ■■■ radioed that the subject was hit.

21:11:32 hours – Unit 38 radioed the subject "went into the house and was unconscious" at E. High Avenue and (unintelligible).

21:14:55 hours – Dispatch asked where the suspect was hit.

21:15:01 hours – Unit 38 advised she was unsure and trying to determine now.

21:15:21 hours – Unit [REDACTED] radioed he had a New Philly police officer with him, and he was ok.

21:15:45 hours – Unit 39 radioed they were rendering first aid to the subject.

21:16:03 hours – Unit 39 advised, "No pulse at this time".

21:16:19 hours – Unit Dispatch radioed that [REDACTED] was on Eighth and Allen Street.

21:16:37 hours – Unit 38 radioed that [REDACTED]'s cruiser is going to need a 31.

21:16:58 hours – Unit [REDACTED] radioed he had a suspect description, "Bald head, beard, blue shirt, jeans, white male".

21:17:05 hours – Unit 38 advised that is who they had.

21:16:56 hours – Dispatch asked Unit [REDACTED] if he needed a 29.

21:17:59 hours – Unit [REDACTED] radioed, "Affirm. I have a new Philly and an EMT standing by with me right now.

21:18:10 hours – Unit [REDACTED] continued, "Be advised I am hit in my left hand".

21:18:21 hours – Dispatch asked if they knew where the subject was hit yet?

21:18:26 hours – Unit 38 answered in the top right shoulder. Unit 38 then said they were on Eighth Street near Allen.

21:25:37 hours – Unit 39 radioed that the registered owner and "victim" was Matthew Flynn.

21:26:25 hours – Unit 35 radioed to have dispatch log that he had [REDACTED]'s duty weapon and camera secured in his cruiser.

It should be noted that the radio traffic provided does not indicate that Unit [REDACTED] was en route too. After units advised they were en route, the next radio traffic provided was Unit [REDACTED] advising to get units there now.
