**Narrative:**

On June 1, 2024, while Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Cory Momchilov (Momchilov) was on scene of this incident, he was informed that the residence of 2125 Tryon Road, Shanon (Shanon) and Dwayne (Dwayne) Turnquist captured cellular phone footage during portions of the incident.

SA Momchilov was further informed that Ashtabula County Sheriff's personnel were able to obtain two cellular phone video clips from Shanon's cellular phone prior to BCI agents' arrival.

Shanon provided SA Momchilov the two cellular phone videos captured by Shanon. The two videos were titled:

- PXL\_20240531\_231206401.TS
- PXL\_20240601\_071515776.TS

SA Momchilov interviewed both Shannon and Dwayne. During those interviews SA Momchilov attempted to have Shannon and Dwayne transfer all cellular phone footage that they captured to SA Momchilov through Evidence.com. The transfer was unsuccessful due to the large file sizes. SA William Conn (Conn) was later able to forensically extract the cellular phone footage captured by Shanon and Dwayne (See Investigative Report titled, "2212 Tryon Rd., Ashtabula Ohio Video Recover" for further detail). SA Conn later provided SA Momchilov with the cellular phone footage.

SA Conn extracted a total of 4 video clips and 1 image related to this incident from Shanon's phone. Those files are titled:

Approximately 20 seconds into the footage, the armored vehicle (David) is observed traveling north (Figure 5)

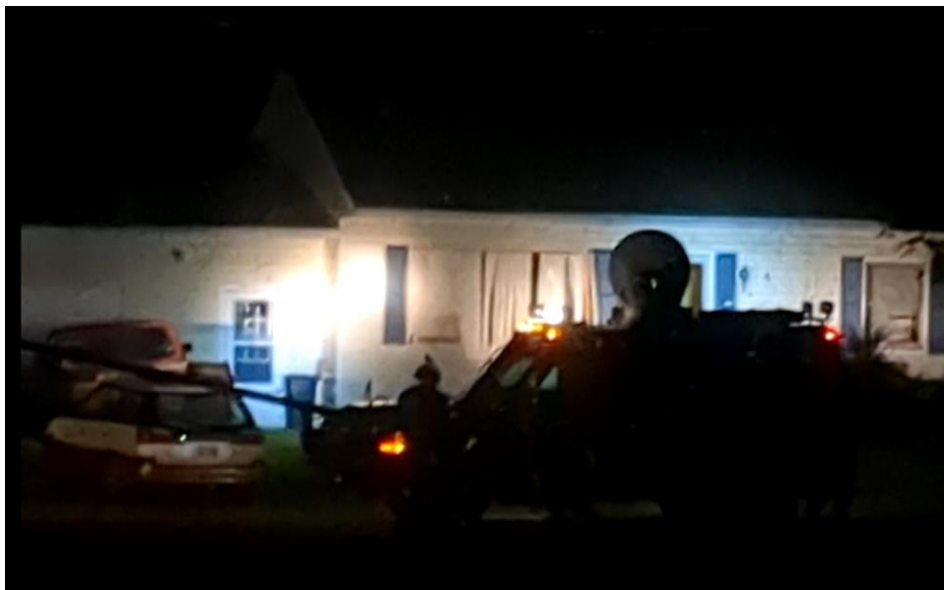

Approximately 59 seconds into the footage, Perry was observed emerging from the window area. Moments later, the sound of gunshots was heard (Figure 7 and 8)

Moments later, a team member was observed running (It is presumed that the team member is Agent Malita, traveling between David and Goliath) (Figure 8 and 9).

It should be noted that this video clip, (PXL\_20240601\_071515776.TS) is the only known footage that captures team members firing. This footage was sent to the Ohio

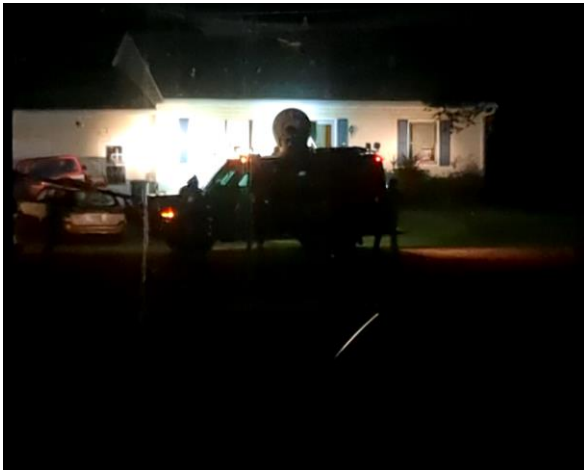

Approximately 3 hours, 4 minutes and 43 seconds into the footage, armored vehicle David was observed approaching the front window of the residence. Moments later, David was observed breaking out the front window of the residence (Figure 32 and 33).

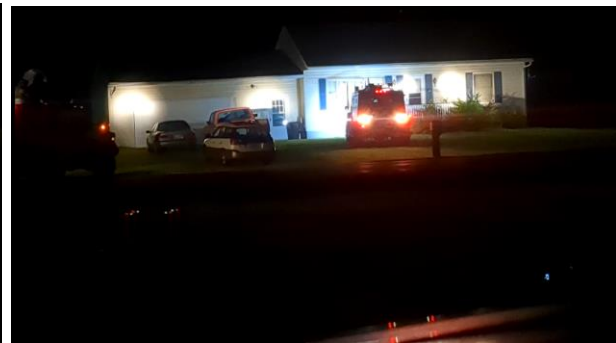

Approximately 3 hours, 5 minutes and 45 seconds into the footage, the turret hatch of David was observed opening. Moments later, a SWAT Team member was observed throwing an item (believed to be the throw phone) from the turret hatch area (Figure 34 and 35). David remained in front of the residence for the remainder of the of the footage. The footage ended prior to Perry firing any shots at the Swat Team members. During the duration of the footage, multiple announcements are heard.

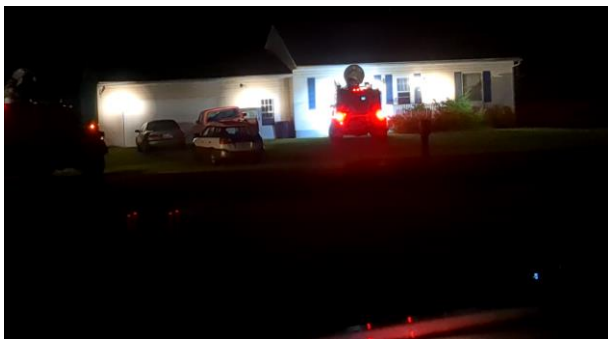
