Eric Cole had driven up to her house in a dark colored SUV and waved a gun out of the window threatening to shoot up a family member's vehicle. Destiny Sudberry advised that Eric Cole then threatened her asking her if she had a problem and wanted some to, while waving the gun around. Destiny Sudberry stated that she feared that Eric Cole would shoot her and called 911 and then left her residence as soon as Eric Cole pulled away from her residence.</p> <p>No charges have been filed at this time.</p>

On 6/14/21 at approximately 0312 hrs. I, Off. J. Emory, was called by Sgt. B. Taylor and requested to respond to 221 W. Johnny Lytle Av. Upon receiving the call from dispatch I observed on MOBILE that the call came in at 2315 hrs. and stated the following copied from MOBILE:

Upon arrival I made contact with a Destiny Sudberry. Destiny Sudberry stated that she is the daughter of Angela Miles and sister of Denajahrae Wells, both who were also present at this address.

Destiny Sudberry stated at the time of the call to dispatch (shown on her phone as 2310 hrs.) Eric Cole drove a dark colored truck (upon speaking further determined to be a SUV) westbound on Johnny Lytle Av. and stopped in front of 221 W. Johnny Lytle Av. Destiny Sudberry stated that she was in front of the residence at this time because Angela Miles had contacted her stating that Denajahrae Wells had told her that Eric Cole was going to shoot up her car. Destiny Sudberry stated that she was getting ready to move Denajahrae Well's vehicle when Eric Cole pulled up in front of the residence.

Destiny Sudberry stated that once the SUV was stopped she observed Eric Cole's hand and part of his arm out of the driver's side window with a handgun in his hand. Destiny Sudberry stated that Eric Cole started waving the gun around and said, "I should bang up this car right now.". Destiny Sudberry stated that she knows that Eric Cole was referring to shooting the car because he was waving the gun at Denajahrae Wells' vehicle. Destiny Sudberry stated that she was scared that Eric Cole was going to start shooting at the vehicle and at her and called 911. Destiny Sudberry stated that she started backing up onto the front porch of her residence at this time and attempted to tell dispatch what was occurring without letting Eric Cole know she had called. Destiny Sudberry then stated Eric Cole then asked her if she had a problem and wanted some to. Destiny Sudberry stated Eric Cole then drove off straight (Westbound) on W. Johnny Lytle Av. Destiny Sudberry stated she was afraid that Eric Cole was going to come back and shoot her and/or her residence and family's vehicles. For this reason as soon as she observed the SUV pass S. Lowry Av. she banged on the door of her house and started yelling for everyone to get out. Destiny Sudberry stated that everyone exited the residence and went to her brother's residence at this time.

I then spoke with Angela Mills (mother of Destiny Sudberry and Denajahrae Wells). Angela Mills stated that Denajahrae Wells had told her that Eric Cole had been texting her threatening messages. Angela Mills stated that she had seen Eric Cole between 8pm and 10pm tonight at the corner of W. Johnny Lytle and S. Lowry Av. Angela Mills stated that Eric Cole had stopped and gave one of her grandchildren \$10.00. Angela Mills stated that Eric Cole appeared to be under the influence of drugs at this time stating, "he had a crazy look on his face.". Angela Mills stated that Eric Cole left and she has not seen him since.

Angela Mills stated that she heard gunshots that she is assuming came from W. Liberty St. (SPD case number 21-24737) and then she observed a dark colored SUV that looked similar to a Ford Explore driving at a high rate of speed southbound on S. Lowry Av. passing W. Johnny Lytle Av.

I asked Angela Mills if she knew who shot Eric Cole and she stated that she does not know for sure (no one told her and she did not witness) but that it may have been "Squeak" or someone in that family. Angela Mills stated that she does not know Squeak's real name. Denajahrae Wells stated that his name is Larry Gilbert and that he is approximately 39 yrs. old and is a skinny black male approximately 6ft. tall.

Angela Mills stated that Larry Gilbert is in a relationship with Denajahrae Wells best friend's mother that resides at 401 W. Liberty St. Angela Mills stated that Larry Gilbert had family including children in that house. Angela Mills stated that they (the parties on scene) were just at 401 W. Liberty) and did not see if the residence had actually been shot or not.

(Narrative Continued)

While I was speaking with there parties Sgt. B. Taylor was speaking with Denajahrae Wells. I spoke with Sgt. B. Taylor who stated that he had gathered information from her stating that this was all stemming from (SPD case number 21-24387) where Eric Cole had assaulted Denajahrae Wells. Sgt. B. Taylor stated that there were text messages on Denajahrae Wells' phone that may be pertinent to this case.

I then spoke with Denajahrae Wells and asked if I could see and photograph her text messages from Eric Cole. Denajahrae Wells gave consent for me to photograph the messages from 6/13/21 to 6/14/21 and pulled up the text messages. I photographed these messages.

I observed on these messages text from Eric Cole (phone number 937-215-7556) threatening Denajahrae Wells. These messages included text stating, "Yeah bitch im finna shoot up every spot!!!"(time stamped at 10:43 PM)
"Wya bitch or im shooting liberty jp" (time stamped at 11:00 PM)
"Im shooting liberty up bitch" (time stamped at 11:02 PM)

I advised Destiny Sudberry that I would be completing an Agg. Menacing report.
