**SUMMARY:**

On Tuesday, July 19, 2022, BCI Special Agents (SAs) Ashley Ornelas, Larry Hootman and SAS Ed Lulla assisted the Ohio State Patrol with the processing of an apartment located at 4851 Westchester Drive, Building A, Apartment 101, Youngstown, Ohio 44515 in regard to an officer involved critical incident. The scene was photographed as it was found and evidence was collected. The scene was further documented using a FARO laser scanner. The scene was processed with the authority of a search warrant.

**DETAILS:**

On Tuesday, July 19, 2022 at 1656hrs, SA Ornelas was contacted by SAS Ed Lulla and was requested to assist the Ohio State Patrol with the processing of an apartment in regard to an officer involved critical incident.

On Tuesday, July 19, 2022 at 1802hrs, SA Ornelas arrived on scene. SA Ornelas was advised that at approximately 1500hrs on July 19, 2022, the Ohio State Patrol was asked to take over a barricaded subject situation. Prior to troopers breaching the apartment, the subject, Imonie Hackett, allegedly fired a weapon. A sniper posted in 4853 Westchester Drive, Building A, Youngstown, Ohio 44515 fired one (1) round striking Imonie.

The residence was in a multi-story, brick apartment building with the main entrance facing north. The apartment was located on the basement floor on the south side of the building. It consisted of a living room, dining room, kitchen, hallway closet, one bathroom, one (1) bedroom and a master bedroom with bathroom. The apartment was in disarray. Clothes were piled up on the floor in the living room and master bedroom. Food was left out in the kitchen and master bedroom. Damage to the main door was reportedly caused by troopers breaching the door. The master bedroom window was also broken reportedly by troopers. Medical equipment and supplies were located on the living room floor (Figure 1, Living Room Overall).

The scene was inspected for suspected ballistic impacts (BI) and several suspected ballistic impacts were located. Two (2) ballistic impacts were located on the window in the living room on the south side of the apartment. A suspected ballistic impact, BI 1.0, perforated the plastic around the window and terminated on the brick around the window (BI 1.2) (Figure 2, BI 1.0-1.2 From Exterior of Apartment). BI 1.0 is consistent with a projectile traveling from inside the apartment to outside when the window was shut. Another suspected ballistic impact (BI 2.0) perforated the double paned window next to the window where BI 1.0 was located (Figure 3, BI 2.0 From Interior of Apartment 101).
