Narrative:

On October 4, 2023, at 0200 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chuck Moran (Moran) arrived at the Ohio State Highway Patrol (OSHP) Post located at 3424 U.S. 422, Southington, Ohio 44470. SA Moran contacted OSHP Trooper

OSHP Trooper **Control** told SA Moran that he did not want to provide a statement to BCI at that time. OSHP Trooper **Control** indicated that he was not injured during the incident. SA Moran provided OSHP Trooper **Control** with a business card and told him to have his legal counsel contact SA Moran to schedule a potential interview or statement. SA Moran left the OSHP Post.

SA Moran did not take photographs of OSHP Trooper because OSHP Sergeant (Sgt.) Jared Klingensmith (Klingensmith) previously told SA Moran that OSHP personnel had already taken photographs of OSHP Trooper after the incident and checked his duty pistol and ammunition magazines.

On October 12, 2023, at 0815 hours, SA Moran received an email from OSHP Lieutenant (Lt.) Daniel Morrison (Morrison). The email had a zipped folder attached that contained multiple photographs of OSHP Trooper in his uniform on the date of the incident. There were also multiple photographs of OSHP Trooper in the solution of a duty pistol and ammunition magazines. The photographs were downloaded, uploaded to Matrix, and were attached to this report.
