NARRATIVE

FELONIOUS ASSAULT / SHOOTING INTO HABITATION / CRIMINAL DAMAGE / NAMED SUSPECT
2024-016109

On Wednesday, January 17th, 2024, while assigned to 4A38, P.O. Reynolds #1236 and I received a radio broadcast to respond to 7702 Canton avenue for a code one shot spotter alert. This is in connection with RMS (2024-015839). We were assisted by members of 4A31 P.O. Ayers #635 & P.O. Lyberger #1547, members of 4A32 P.O. Kane #997 & P.O. McCartney #820, members of 4A35, P.O. Blocton #32 & P.O. Morrison #1017, member of 4S33, Sgt. Wills #9321. We were also assisted from members of the 2nd, 3rd and 5th district, along with various support units. Below are the details of the incident.

After the initial incident of RMS (2024-015839), we began to tour the area to ensure no persons or property had been harmed or damaged. I knocked on the residence of [redacted] avenue, and was met by [redacted] (Victim 1) and [redacted] (Victim 2) at the rear door. [redacted] said that around 1839 hours they were sitting on their living room couch and multiple rounds of gun fire came through their living room windows coming with (1 1/2 feet) from striking them. [redacted] said that as the shot came through they went onto the living room floor and contacted police. I observed multiple bullet strikes within their home approximately 10-13 rounds have entered through the windows on the East side walls. I observed the following items in the house have been struck, Ipad screen, Glass shower door and the window air conditioning unit. [redacted] said that it was neighbor Robert Perkins (suspect) who had fired the rounds into his home. I had provided [redacted] with the victim crime packet and a copy of the RMS number.
