Narrative:

On January 12, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente (Valente) requested the Ohio Organized Crime Investigations Commission (OOCIC) sync surveillance camera footage from the Barberton YMCA, Sitting Pretty Hair and Nail Boutique, Barberton Police Officer Velo's body-worn camera video, and Barberton Police Officer Shields' body-worn camera video.

SA Valente completed the OOCIC Evidence Submission Form, along with an attachment which outlined SA Valente's request. SA Valente provided a thumb drive with the videos to be reviewed to OOCIC for analysis. The forms and thumb drive were mailed to OOCIC. The analysis request (PDF of the submission form and attachment) and mailing receipt are attached to this report.

Ohio Organized Crime Investigations Commission,

My name is Nick Valente and I am a Special Agent with the Ohio Bureau of Criminal Investigation. I am currently investigating an officer involved shooting which resulted in the death of the subject. This incident occurred on December 26, 2022, in Barberton, Ohio.

During the course of this investigation I have obtained the following relevant video recordings:

- 1. Body worn camera footage collected from the Barberton Police Officer who is alleged to have shot the subject.
- 2. Body worn camera footage collected from a Barberton Police Officer who was involved in the incident and witnessed the shooting.
- 3. Surveillance video from the Barberton YMCA which recorded the event that is the subject of this investigation.
- 4. Surveillance video from Sitting Pretty Hair and Nail Boutique which recorded the event that is the subject of this investigation.

I am requesting your assistance as follows:

- One production of each video file including a frame counter and audio wave bar (where applicable) for the times specified below.
- A separate production which includes all four videos synced if possible.
 - If possible, could the second production be created to include:
 - Audio wave bars (where applicable) and a frame counter
 - One production at full speed
 - One production at half speed

The video file titled "CH02-2022-12-26-10-01-18_10-21-21" was created from a neighboring business, Sitting Pretty Hair and Nail Boutique, surveillance camera recording. The relevant portions of this video which I am requesting be analyzed begin at 7:08 into the video (which is wrongly time-stamped on the recording as 10:08:26) and ends 12:00 into the video.

The video file titled "2022-12-29 - 24 7 Door 1_20221226_085655" was created from a neighboring YMCA surveillance camera recording. The relevant portions of this video which I am requesting be analyzed begin at 4:45 into the video and end at 9:27 into the video.

The video file titled "**BWC**" was created from a body worn camera recording of a witness officer. The relevant portions of this video which I am requesting be analyzed begin at **0:20 into the video and end at 5:05 into the video**.

The video file titled "**Generation** BWC" was created from a body worn camera recording of the involved officer. The relevant portions of this video which I am requesting be analyzed begin at 0:35 into the video and end at 3:08 into the video.
