The suspect began texting the victim and the victim attempted to clarify his statement and engaged the suspect in a conversation. The suspect began using racial slurs and become nasty, so the victim stopped responding. The suspect then sent a final text calling the victim more racial slurs and then made a statement, "I think about killing all you racists. I'll kill myself and take you all with me." The victim advised that he is fearful something could happen. The victim was advised that a report would be taken documenting the incident.
