DEAR SIR:—Permit me to acknowledge the receipt of your letter of May 9th in which you request my approval of a synopsis you submit relative to House Bill No. 249, said synopsis to be used in connection with a referendum petition which you state yourself and others desire to file.

The act against which you propose to file a referendum petition is declared upon

its face to be an emergency law necessary for the immediate preservation of the public peace, health and safety, with the reasons for such necessity set forth in the act. As laws of that character are expressly exempted from the referendum, it is my judgment that in this case I should decline to take any action in aid of such a course, and I therefore decline to approve the synopsis submitted.
