Upon my arrival we met with victim [REDACTED] who stated at 0715 hrs today she was leaving home to take her kids to school. Victim stated that she stopped in her driveway to make sure her kids seatbelts were on. Victim stated suspect Robert Perkins was outside yelling "I'll hang you like the baby doll on my fence." (There is a baby doll head hanging off suspects fence) "I cant stand you bitches." "I'll burn that fucker down." Victim stated this isn't the first time he was threatened her.
