

Narrative:

On April 3, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente and SA Joe Goudy interviewed Trumbull County Sheriff's Deputy (Deputy was accompanied by his attorney, George Gerken of the Ohio Patrolman's Benevolent Association. The interview took place at the Trumbull County Sheriff's Office and was audio and video recorded. The audio recording has been attached to this report. The video recording has been stored in the BCI SIU case file as Reference Item H.

Prior to beginning the interview, Deputy read, indicated he understood, and signed the BCI Criminal Investigation Notification Form. That form has been attached to this report.



The officers and troopers discussed their concerns about the subject being inside a hunting cabin. The officers and troopers were aware there was a crossbow inside the cabin and did not know if the subject had any additional weapons. The group learned from the property owner that the cabin had four sides, each with a window the subject may attempt to jump out if he observed law enforcement approach the cabin.

The group devised a plan to park in the roadway and approach the cabin on foot. Two officers or troopers would position themselves on each side of the cabin. Once everyone was in place someone would drive a marked car down the driveway to the cabin and start making verbal announcement to the subject (to surrender and exit the cabin presumably).

Deputy described the walk down the sidewalk as dark but some visibility still being present. As the group approached the cabin they heard music playing that appeared to be coming from the cabin. The group, unaware of the subject's location, continued to approach the cabin and noticed a truck parked alongside the cabin. Deputy used two business cards to show agents just how close the truck was parked to the cabin.

Deputy who was assigned with Brookfield Township Sergeant (Sergeant to position himself along the side of the cabin that had the door. As officers approached they found the door was obstructed by the truck.

As the group made their way closer to the cabin, someone stepped on a "a little twig, and when I say like a little twig it wasn't like a loud branch snapping it wasn't like a 'KAPOW' I mean it was just faint" [28:15 mark of video]. Deputy then described seeing the subject react to hearing the twig break and that surprising him. The subject then sprung up and Deputy was caught off guard and began thinking "no way, what's gonna happen, what's gonna happen" [28:58 mark of video]. The subject then began to look out the window and an unknown officer shined a flashlight directly on the subject and began announcing "Police! Police!" Deputy then himself began to yell out "Police!"

The subject then dove out the window of the cabin and into the truck very quickly. Deputy then began using the barrel of his gun to try and break out the passenger window of the truck but was unsuccessful. Deputy described the look on the subject's face at the time by stating "I've seen some looks in people's faces but I will not forget the look on this guy. Like, looking as fast as all this had transpired, I remember just looking at him and like he had like this different look into his eyes, like, I don't know how to describe it the best but it was, it was a look of uh, he had a uh objective he wanted to, to get and he just, there was, there was nobody home. I don't know if that makes sense. Um, but he was, he was fumbling around trying to get the keys going and I kept striking the passenger window with my AR15 and somehow during this point that's when my magazine fell out. I didn't know that and I'll never forget how strong that window was [29:44 mark of video].

Deputy stated the subject was able to start the truck and "just pedal to the floor 'cause it's hard compressed dirt. It's not like there's a driveway there and if there was any type of gravel it was so far compressed down in there. Just peels out and he takes off right where the troopers are going. I know I wasn't the first to shot or to shoot rather. Um, I just remember going like this [demonstrates aiming a rifle with his hands] from a low ready and going up and I'm like why isn't my gun firing? Well, I look over and I'm like my magazine, and I'm like do I throw my gun on the ground, do I do an emergency reload, do I grab my pistol and by that time everybody was done shooting. I got on the radio and I said I need a squad on the red" [30:47 mark of video].

In concluding his recollection of the event, Deputy stated "he (Wild) was an imminent threat and if we did not discharge our firearms to protect the troopers, and you know, I'll refer to them as my friends because I'm good friends with all them guys, you know, there isn't many

people on midnight shift, especially in the areas we patrol. So, if somebody's coming it's gonna be those guys. If we did not discharge our weapons to protect them from serious physical harm I believe he would have seriously injured one of them or killed one of them, I mean he ran over a tree" [32:21 mark of video].

When asked, Deputy stated he never heard the subject say anything during the encounter.

When asked if he could see where the officers and troopers were when the truck began to accelerate, Deputy stated "I knew they were in the front but I couldn't tell ya, like hey this guy is 6 feet away from this guy" [45:25 mark of video].

When asked what lead him to fire his weapon, Deputy stated "Because I thought he was gonna run over the guys I was with. Seriously, physically injure them or kill 'em, I mean, the guy, he uh, and we all knew that he was in two uh, two chases, he ran from 'em, he had the felony warrants, I mean we all knew that this guy was a severe flight risk. And the fact that he was in a stolen truck and ya know committing a B and E none the less. We knew this guy was gonna do whatever he could to escape [49:00 mark of video].

When asked if he pulled the trigger a second time or how he figured out the weapon was not working, Deputy stated he did pull the trigger a second time and the trigger was really tight, he then looked at the rile from the side and confirmed the magazine was no longer seated in the rifle.

Deputy stated he believed his actions and the actions of the other officers were consistent with his training.


