Investigative Activity: Body Camera Review

#### Narrative:

On Thursday, December 14, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) received video footage from the Garfield Heights Police Department (GHPD) Sergeant (Sgt.) Todd Cramer (Cramer). SA Goudy was informed that the videos contained footage from the body cameras recorded by the Garfield Heights Police Department (GHPD).

SA Goudy reviewed the video recordings and noted the following:

(Duration: 23 minutes and 02 seconds)

At the 01:30 mark, is seen walking up to the front door of 6235 Hathaway to make contact with the homeowner.

At the 02:23 mark, a female opens the door from the residence. The female was later identified as Wilma Russell (Wilma). The wife of the decedent Benard Russell.



At the 02:48 mark, Wilma lets and and into the residence. After advised Wilma of the 911 call received from someone in the residence asking for the suicide hotline, Wilma said it could be her husband and that he's alone in the basement. When Wilma was asked if there were any weapons in the house, she said no.

At the 03:14 mark, and and approach the interior door to the basement from the kitchen. When tries to gain entry, the door is locked.

Calls out Benard's name but there was no response.



At the 03:25 mark, asked Wilma if Benard was having any troubles. Wilma stated they had a conversation about divorce earlier in the morning.

At the 04:49 mark, used the keys and opened the door to the basement where Russell was located. It is heard yelling Russell's name and identifying herself as Garfield Heights Police prior to her entering through the doorway.



At the 05:09 mark, seem is seen walking into the basement where she encountered Russell in another room sitting in a chair at the far end of the room.

At the 05:11 mark, has her flashlight on Russell which reveals Russell holding a handgun to the right side of his head. At this point, his pleading with Russell to put the gun down.









At the 07:39 mark, While is pleading with Russell to put the gun down, Russell is heard saying, "We all die, we all die." Russell is saying this while still holding the handgun to the right side of his head.

At the 11:55 mark, as is still trying to get Russell to lower the gun, Russell is heard saying, "we all die" continuously, followed by, "it's time to die." tells Russell, "It's not time for you to die Benard."



At the 14:47 mark, after several attempts of negotiations with Russell by Russell lowers his gun towards which resulted in firing her duty weapon at Russell.





At the 05:49 mark, after officers arrived at the location, Officer Cwiklinski and other officers began to enter the rear exterior door of the basement. During this time, could be heard negotiating with Russell.









At the 08:45 mark, stopped firing her duty weapon. Officer Cwiklinski is seen moving up and Russell is heard in the background moaning in pain. Officers are heard yelling for Russell to drop the gun.

ADDITIONAL FACTORS FOR EVALUATING THE VIDEO RECORDINGS There are numerous other factors that need to be considered when reviewing and evaluating the videos and audio recordings of this incident. Those factors are:

A. Video recording devices record within the video and sound capabilities available, and they record objectively. Video recordings lack the history, perspective, and interest of the people involved. The positions, angles, obstacles, lighting, and distance from the incident are also factors that need serious consideration.


B. Video recording devices also record more information about a particular scene or incident than the person(s) involved in the incident can process during the critical incident. Video recording devices rarely record an event from the same perspective of the officer. It captures the action but not the perception, decision making, focus, or intent of the officer. Video recordings often miss tactile cues or other actions of a subject.

C. The speed of the incident is remarkable. The speed and complexity of rapidly evolving situation(s) that occur during use of force encounters are difficult concepts to comprehend by only watching the video.
