**Narrative:**

On Tuesday, July 30, 2024, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Joseph Goudy (Goudy) received the personnel file for Sheriff Terry Grice (Grice) from Medina County Sheriff's Office (MCSO) Captain Eric Bors. SA Goudy reviewed the personnel file and noted the following:

Sheriff Grice has been the Medina County Sheriff since January 4, 2021. Prior to that, he was employed as the Chief of Police with the Montville Police Department from November 14, 2011 to January 4, 2021. Overall, he was employed with the city of Montville police department for approximately 22 years.

Training:

Sheriff Grice attended the Medina County Sheriff's Training Academy on January 25, 1999, and completed it on July 7, 1999. (BAS #99-025 - Certificate #991208)
