Narrative:

On Thursday, December 19, 2024, at 1341 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Chad Holcomb (SA Holcomb) and SA Aja Chung (SA Chung) interviewed Sheryl Nevil (Nevil), relative to the officer-involved critical incident which took place on Thursday, December 19, 2024. The interview took place at her place of employment, Doyle HCM located at 735 Taylor Road, Gahanna, Ohio. The purpose of the interview was to obtain all relevant information about the incident known or observed by this individual.

Nevil stated that she works at Doyle HCM as a team manager and witnessed the OICI.

Nevil said that she was on the second floor, corner office, having a meeting with the blinds closed. A co-worker stated that they saw emergency lights on a cruiser. They looked out the window and saw the subject, walking through the parking lot, with a handgun in his right hand, down at his side. The subject was walking away from the officers.

The subject looked back at the officers once but never raised the firearm. He then walked across Taylor Road (northbound) with no regards to oncoming traffic. She then sees the subject go behind a set of bushes. Shortly after, she heard the gunshots. She believes she heard ten (10) to fifteen (15) gunshots.

Nevil said that she couldn't hear if the officers or the subject ever said or yelled anything.

SA Holcomb asked Nevil if she believed that the officers on scene were well represented as law enforcement. She replied with, "Yes".

Nevil recorded two videos of the OICI. The videos have been uploaded to Evidence.com for review.

The interview concluded at approximately 1445 hours.
