HANEFELD, Director, Department of Agriculture, Columbus, Ohio DEAR SIR:—The Chief of the Bureau of Inland Lakes and Parks of the Division of Conservation in your department has submitted for my examination and approval a reservoir land lease, in triplicate, executed by the Conservation Commissioner to one Noel J. Cramer of Pickerington, Ohio.

By this lease, which is one for a stated term of fifteen years and which provides for an annual rental of \$36.00, payable semi-annually, there is leased and demised to the lessee above named the right to occupy and use for business, cottage site and docklanding purposes a triangular-shaped parcel of reservoir property at Buckeye Lake, located in the northeast quarter of the southeast quarter

of Section 28, Township 17, Range 18, Fairfield County, Ohio, which parcel of land is more particularly described as follows:

"Beginning at the southwesterly corner of the Leib's Island bridge and running thence southwesterly along the southerly side of said road, six hundred (600) feet, more or less, to the northeasterly water line of the Kirkersville Feeder; thence southeasterly and northeasterly along the northerly water line of said feeder, seven hundred (700) feet, more or less, to the place of beginning and containing two-thirds (2/3) of an acre, more or less."

DEAR SIR:—This is to acknowledge the receipt of a recent communication over the signature of the Chief of the Bureau of Inland Lakes and Parks of the Division of Conservation in your department, submitting for my examination and approval a reservoir land lease, in triplicate, executed by the Conservation Commissioner, under authority of section 471, General Code, to one J. R. Beatley of Russells Point, Ohio.

This lease, which is one for a stated term of fifteen years, and which provides for an annual rental of \$225.00, payable semi-annually, grants and demises to the lessee above named the right to occupy and use for docklanding, garden, lawn, general business and driveway purposes, the waterfront and State reservoir land in the rear thereof at Indian Lake, Ohio, which parcel of land is more particularly described as follows:

"Beginning at an iron pin at the northwest corner of Lot No. 15, of Burkhardt's Allotment of lands at Russells Point and extending thence
