On Monday, May 23rd, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Aja Chung drove to the Hamilton County Coroner's Office to retrieve evidence items collected from the autopsy of Camille Weems. At 1100 hours, SA Chung received the items listed below. SA Chung returned to BCI offices in London, Ohio, where the items were photographed, labeled and repackaged.

Item #	Description
1	Personal effects: one pair of shoes, one pair of socks, pants; "code cuffs"
2	.223 projectile inside bullet box; recovered from Weems' body; Hamilton County coroner #: CC22-01877 with markings: L. side back
3	Nail clippings, hair, blood card, nail clippers

All three items were secured in the crime scene temporary locker at 1400 hours.

On Thursday, May 26th, 2022, SA Chung drove to Miami Township Police Department (MTPD) to retrieve a .223 casing that was located and collected by MTPD personnel on the roof of MTPD cruiser [REDACTED]. At 1202 hours, SA Chung collected the casing from MTPD Evidence Officer Wahlert.

At 1330 hours, SA Chung returned to BCI offices in London, Ohio where she photographed the .223 casing and labeled it item 18 from scene 1 (947 SR-28, Milford, OH).

SA Chung then retrieved the secured items from the crime scene temporary locker at 1358 hours and submitted the following items to the BCI laboratory:

- Items 2, 10, 11, 14: 9mm Hornady casings
- Item 3: Sig Sauer rifle
- Items 4-8, 18: .223 Speer casings
- Item 9: Taurus pistol
- Item 13: .223 projectile
- Item 16 -17: projectiles from Harkey's motorsports
- Item 2 (scene 2): projectile from autopsy
