Narrative:

On Tuesday, July 22, 2025, SA Boerner began reviewing the assigned BWC – Dash Cam recordings (*Table 1 – List of Brooklyn BWC – Dash Cam*). The recordings were stored in and accessed via Axon Justice (Reference Item N – BWC and Dash Cam > Brooklyn PD BWC-Dash Cam). Each recording was reviewed in its entirety and Evidence Markers were placed in the recordings at points relevant to the investigation (See attached Evidence Marker Reports for further). Any BWC – Dash Cam deemed to be relevant to the investigation was moved to a sub folder titled “*Relevant Brooklyn PD BWC and Dash Cam*”.

- At approximately 12:31:24hrs, Kerr stated, "I wish I would've done it the other night (the remaining portion of his statement was undiscernible)."
- At approximately 12:32:10hrs, Kerr stated the following:
 - "I wanna hurt myself."
 - "I wanna kill myself."
 - "I got a gun to my head."
 - "You guys are going to kill me if I step out of the car."

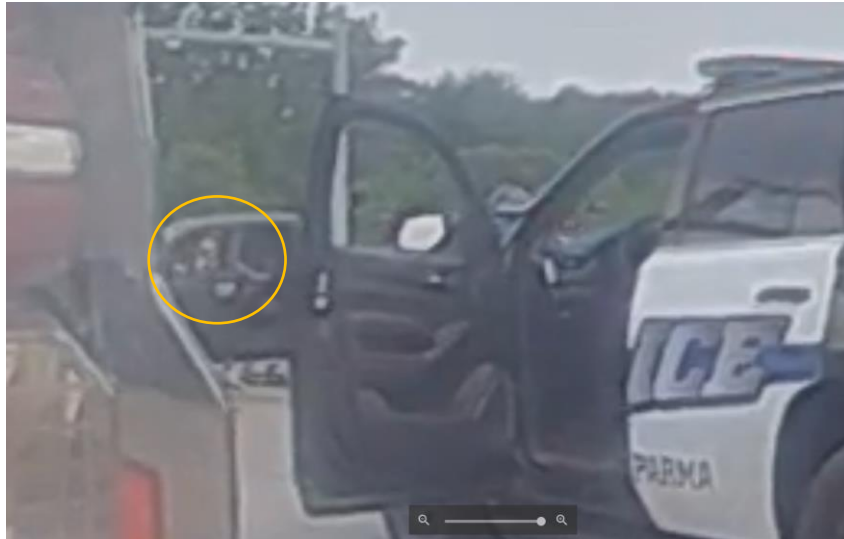


Figure 1, Snippet - Kerr with hand to head

- At approximately 12:37:01hrs, Kerr is actively speaking with officers and appears to have his right hand to his head (*Figure 1, Snippet - Kerr with hand to head*).

- At approximately 12:39:27hrs, an unknown officer was recorded stating, "He's putting the gun in a bag."
- At approximately 12:44:22hrs, officers discussed moving out of the scene once the armored vehicles (bearcats) are in place.
- At approximately 12:50:15hrs, officers are directed to fall back to the Brooklyn Fire Department.

- At approximately 11:56:25hrs, officers discussed the initial reason for the traffic stop, pursuit, Kerr's use of pills, and Kerr's use of suspected narcotics (marijuana).
- At approximately 12:04:10hrs, Kerr can be heard talking with officers and says, "Fuck you!"
- At approximately 12:19:34hrs, SWAT can be heard advising Kerr of their movements to check on the driver in the white Nissan.
- At approximately 12:45:01hrs, officers clear the immediate area as SWAT moves in position.
